## TRAINING DATES AND TIMES

Urban Vybe's 200hr Yoga Teacher Training is an accredited Yoga Teacher Training and is a registered Yoga Teacher Training School with Yoga Alliance, the governing body in the U.S. for Yoga Teacher Training Schools.

Classes will meet Monday through Thursday from 9:00am - 2:30pm.

## Terms and Conditions

Please carefully read the following terms and conditions relating to your participation in the Urban Vybe 200hr Yoga Teacher Training, which is conducted by Urban Vybe LLC ("Urban Vybe"). By registering for the Urban Vybe 200hr Yoga Teacher Training, you (the Student) signify your acceptance of and obligation to these terms and conditions.

## General Privacy Policy

Let yourself be free. Anything said or done during our Yoga Teacher Training will be held in confidence by all attendees.

## Cancellation Policy

The Student's registration form, liability waiver, and a \$500 deposit must be submitted to Urban Vybe by October 11th, 2017 to secure their spot in the Urban Vybe 200hr Yoga Teacher Training. The Student's full tuition payment must be paid to Urban Vybe, or a payment contract must be set up by Urban Vybe before October 11th, 2017 in order to attend the training. If the registered Student has paid the full deposit for the Urban Vybe 200hr Yoga Teacher Training and cannot attend the training, the Student must notify Urban Vybe in writing before October 1<sup>st</sup>, 2017 to receive a full refund for the \$500 deposit. If Urban Vybe receives the Student's cancellation notification after October 1<sup>st</sup>, 2017, the deposit is non-refundable. If the Student has paid the full tuition payment for the Urban Vybe 200hr Yoga Teacher Training, but cannot attend, the registered Student must notify Urban Vybe in writing before October 1<sup>st</sup>, 2017 to receive a full refund for the tuition payment. If the registered student does not notify Urban Vybe in writing before October 1<sup>st</sup>, 2017 all fees are non-refundable. The registration and payment can be transferred to another student pending approval from Urban Vybe. If the original Student cannot attend and cannot find a replacement by October 1<sup>st</sup>, 2017, all fees will be forfeited to Urban Vybe.

Once the Urban Vybe 200hr Yoga Teacher Training has begun, there are no refunds. If the registered Student drops out of the training or fails to complete the requirements of the training, no refunds will be given. The Student does have the option to finish the training by joining the next Urban Vybe 200hr Yoga Teacher Training for a discounted rate of \$1,500, and upon the completion of all the requirements of the training, the Student will be eligible to graduate.
